

## Schedule of Fees – WSS Online – for the Master Agreement on the Delivery of Securities Information from the WSS Securities Service System of Deutsche Börse AG

Effective as of July 2023

With the WSS Online product, Deutsche Börse AG provides the following data online:

- data of Wertpapier-Mitteilungen (WM), Frankfurt/Main
- share price and turnover data of Deutsche Börse AG
- closing prices of foreign stock exchanges from Refinitiv Germany GmbH
- Clearstream Banking AG's securities basic master data
- master and corporate action data (corporate actions and income event data) of Deutsche Börse AG (PROPRIS®)

This data can be accessed using WSS-Online Plus via web browser.

## A Fees for using WSS-Online Plus

## A.1 Service fee for access to: data of Herausgebergemeinschaft WERTPAPIER-MITTEILUNGEN Keppler, Lehmann GmbH & Co. KG, Frankfurt/Main

- share price and turnover data of Deutsche Börse AG
- closing prices of foreign stock exchanges from Refinitiv Germany GmbH
- Clearstream Banking AG's securities basic master data
- master and corporate action data (corporate actions and income event data) of Deutsche Börse AG (PROPRIS®)
- master and corporate action data from Exchange Data International (EDI)

The service fee is calculated per query on WSS Online Plus:
