Full-version files contain all share prices of the respective stock exchange contained in the WSS database.

Change-version files exclusively contain the changes in share prices against the previous day.

The files are made available to the customer in the respective record format.

Deutsche Börse will notify customers of changes in the record formats or key expansions in the tables in a timely manner, so that they are able to perform inhouse applications on schedule. This does not apply to the transit of data of the WM Data Service. Files are provided in WM-record format.
