Licensing of Santiago Exchange Information as of 1 October 2022

Santiago Exchange and Deutsche Börse - Data Services have entered into a market data cooperation. As of 1 October 2022, the new Information Product Santiago Exchange Indices and Spot Market will be available via Deutsche Börse AG who acts as an additional licensor. The Information Product can be ordered now in MD+S interactive.

Price and licence adjustments of Information Products as of 1 January 2023
